



## **Cumulation in the EU Economic Partnership Agreements with ACP countries**

*Updated on 04.07.22*

The table below summarizes the current possibilities for EU operators to apply cumulation when exporting under the framework of an Economic Partnership Agreement (EPA) with ACP countries in force. The table builds on the recent implementation actions by the European Commission and the various notices recently published in the Official Journal (C Series) of the EU.

All EPAs in force provide for cumulation in the EU whereby EU operators can benefit from bilateral and diagonal cumulation of non-originating materials and of working or processing carried out in certain ACP countries and OCTs.

The said cumulation is subject to the fulfilment of the specific requirements provided for in the respective Protocols on rules of origin.

### **Notes**

- a) The columns indicate the EPA under which the EU operators are exporting;
- b) The rows show the countries with whom the EU may cumulate;
- c) "√" indicates that full<sup>1</sup> and diagonal cumulation apply in the context of the indicated EPA;
- d) "√\*" indicates that full<sup>1</sup> and bilateral cumulation applies in the context of the indicated EPA;
- e) § – exports from the EU to Cameroon are governed by Cameroonian Decree No 2016/367 of 3 August 2016
- f) (1) Exclusions of materials that can be used for cumulation applied, see Notice 2022/C 211/07
